
ORDER

- WHEREAS, in terms of Sub-clause (10) of Clause 8 of National Council of Teacher Education (Recognition Norms and Procedure) Regulations - 2014 and Section 26A of the West Bengal of Primary Education (WBPE) Act (amended up to date), 1973, the Senior Lecturer-in-Charge, District Institute of Education and Training, Bankura has applied for grant of renewal for continuing the DEEd Course on 24/03/2023, Memo No. 176/E.No.-1/DIET-BNK-23 (the hard copy of the paper has been received by the West Bengal Board of Primary Education(WBBPE) on 26/06/2023).
2. AND WHEREAS, on scrutiny of the application submitted by the institution, the certificate stating recognition received from the Eastern Regional Committee of NCTE dated 18/03/2017 under memo No. E.No.234.12.17(Part - 4)/ERCAPP 2146/D.DELED (Addl. Intake)/2016/51691 and the report of inspection of the Committee duly formed by the WBBPE, the recognition Committee of the WBBPE is satisfied that the application fulfills the requirements under the provision of West Bengal Primary Education Act (amended up to date), 1973, Regulations and the relevant Rules including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc. for running the programme.
3. NOW THEREFORE, in exercise of the powers vested under section 26A of the West Bengal Primary Education (WBPE) Act (amended up to date), 1973, the President of the WBBPE and the Chairman of the Recognition Committee hereby grants renewal of recognition to District Institute of Education and Training, Bankura , for conducting 2 (two) year D. El. Ed course with an intake capacity of 100 (One Hundred) for the period of the academic years, w. e. f. 04/05/2017 to 03/05/2020 , on post facto basis as the institute undertakes that the following conditions were maintained accordingly:-
- The institution shall comply with various other norms and standards prescribed in the WBPE Act, (amended up to date), 1973 and other WBBPE regulations/rules as issued from time to time.
 - The institution shall make admission as per regulations/norms of the WBBPE.
 - The institution shall ensure that the required number of academic staff duly approved by the WBBPE for conducting the course should always remain in position.


